THE FOREST ENACTMENT (No. 58).

EXTENSION TO PULAI FOREST RESERVE.

No. 1075.—In exercise of the powers conferred upon him by section 3 of the Forest Enactment and in pursuance of section 12 thereof; the State Secretary, with the approval of His Highness the Sultan in Council proclaims that the land described below shall be a reserved forest in extension to and forming part of the Pulai Reserve.

DESCRIPTION.

District—Pontian. Mukim—Serkat. Approximate Area—1,500 acres.

Boundaries:—

North:—Between the survey mark numbered 71/21 on the southernmost corner of lot 155 and the Straits of Johore the Reserve is bounded in succession by lots 155, 441, 442, 805 and the Sungei Pulai Forest Reserve.

East and South:—Then the Straits of Johore, and the Straits of Malacca to a point due South of the survey mark numbered 88/570 on lot 709.

West:—Beyond the last mentioned point the boundary runs due north to C. M. 88/570, then along the southeastern boundaries of lots 709, 713, 1712, 1713, 259 and 260 to its easternmost corner; thence along cut lines on the bearings and distances as follows:—
