THE FOREST ENACTMENT (No. 58).

No. 149.—In pursuance of section 4 of the Forest Enactment the State Secretary hereby declares that it is proposed to constitute the land described in the Schedule hereto a reserved forest in extension to and forming part of the Labis forest reserve.
