FINAL NOTIFICATION OF PANTI FOREST RESERVE.

In exercise of the powers vested in him by section 3 of "The Forest Enactment, 1921", and in pursuance of section 12 thereof, the State Secretary, with the approval of His Highness the Sultan in Council, hereby proclaims that, with effect from 1st April, 1929, the land described below and delineated upon plan no. 43 (provisional) in the Office of the Conservator of Forests, Johore Bahru, shall be a Reserved Forest,—to be known hereafter as Panti Forest Reserve.

District Kota Tinggi Approximate area ... 26,394 acres.

. Boundaries.

North. Commencing from a point on the West bank of a tributary of the Sungei Susor Rotan immediately opposite to the Western corner of old lot 769; thence the Western bank of this tributary to its source; thence a straight line to the Northern extremity of old lot 533; thence a straight line due East to the Sungei Merbau; thence the Eastern bank of Sungei Merbau to its mouth; thence the Southern bank of Sungei Dohol to lot 257; thence the Eastern, Southern and Western boundaries of that lot; thence the Southern bank of Sungei Dohol to its mouth; thence the Southern bank of the Sungei Sedili Besar downstream to the mouth of Sungei Mawai.

East. Thence the Western bank of the Sungei Mawai upstream to lot 553; thence the Northern, Western and Southern boundaries of that lot to the Sungei Mawai; thence the Western banks of the Sungei Mawai and Mupor upstream to lot 895; thence the Northern, Western and Southern boundaries of that lot to the Sungei Mupor; thence the Western bank of the Sungei Mupor upstream to the point of intersection of the Kota Tinggi-Mawai road; thence the road reserve Southwards to lot 79; thence lot 79; thence the road reserve to lot 603; thence lots 603 and 120; thence the road reserve to lot 88; thence lots 88 and 87; thence the road reserve to lot 323; thence lots 323 and 254; thence the road reserve to lot 30.

South. Thence the North Eastern boundary of lot 30 to its North Eastern corner; thence a straight line on a bearing 328° approximately for a distance of 3 miles; thence a straight line to the Eastern extremity of lot 752.

West. Thence in a North Westerly direction following the boundaries of lots 752 and 202 to the Eastern bank of the Sungei Pelepah Kanan; thence the Eastern bank of this river upstream to lot 199; thence the Northern boundaries of that lot to the Sungei Pelepah Kanan; thence the Northern bank of that river to its source; thence a straight line to the source of the tributary of the Sungei Susor Rotan; thence the Eastern bank of that tributary to its source; thence the Southern bank of the Sungei Susor Rotan to the point of commencement.
