

THE FOREST ENACTMENT, 1921.
FINAL NOTIFICATION OF FOREST RESERVE, ENDAU,
UNDER SECTION 12.

No. 312.—In exercise of the powers vested in him by section 3 of the Forest Enactment and in pursuance of section 12 thereof, the State Secretary, with the approval of His Highness the Sultan in Council, proclaims that with effect from the first day of October, 1923, the land described below and delineated upon plan No. 1 (provisional) in the office of the Conservator of Forests, Johore Bahru, shall be a reserved forest, to be known hereafter as the Jembaluang Reserve.

DESCRIPTION.

<i>District.</i> ...	Endau.
<i>Approximate area</i> ...	20,000 acres.

BOUNDARIES.

North and North-east.—The sea coast from the mouth of the Sungei Jembaluang to the mouth of the Sungei Tenggaroh.

South.—The Sungei Tenggaroh upstream for about three miles, thence a line due west to the eastern extremity of lot No. 20.

West and North-west.—Lots 20, 23, 24, 1079, 1078, 1332, 1078, 1077, 55, and 78 to the northern extremity of the last named; thence a line running approximately north-east by north to the Sungei Jembaluang; thence the Sungei Jembaluang to its mouth.

The following rights are admitted and privileges granted within the reserve, but the exercise thereof shall be subject to the control of the Conservator and to such orders as he may make with the approval of the State Secretary, to regulate the local limits within which, and the mode in which, the produce referred to may be taken or received within the reserve.

1 (a)	The inhabitants of Kampong Kuala Jembaluang to a maximum of 40 households.	For a period of 21 years from the date of reservation: the right to take from the Jembaluang Reserve. A. Kamap, Leban, Petaling and trees of Class I C.D.&E. as defined by the schedule to the Forest Rules for the time being in force, provided that such timber is for the construction and repair of dwelling houses for the permanent abode of themselves and their families, for the construction of temporary huts on and for the fencing of their own lands, or for the construction and repair of any work for the common benefit of the right-holders.
(b)	The inhabitants of Kampong Kuala Sekakap to a maximum of 10 households.	B. Timber of the above Classes and of Class IB for the construction and upkeep of fishing boats and sampans for their own use. C. Firwood and bark of Class ID as defined by the Forest Rules for the time being in force; palm leaves for ataps, wood oil, rotan, damar, and creepers, provided that such produce is for their own personal or domestic use, or for any work for the common benefit of the right-holders

NOTE.—Lot No. 5 and all lands already alienated or the alienation of which as been approved and which fall within the boundaries of the reserve are excluded from the above reserve.
