

THE FOREST ENACTMENT, 1921.

NOTIFICATION OF PROPOSED FOREST RESERVE, BATU PAHAT,
UNDER SECTION 4.

No. 392.—In exercise of the powers vested in him by section 3 of The Forest Enactment, 1921, the State Secretary hereby notifies that it is proposed to constitute the area described below a Reserved Forest.

GUNONG BANANG.

<i>District</i>	Batu Pahat.
<i>Approximate area</i>	1,500 acres.

DESCRIPTION OF BOUNDARIES.

North.—From the southern extremity of lot No. 31, the southern boundary of that lot and lots 128, 493 and a line to the south-west corner of lot 495 (adjoining the impounding reservoir No. 2.)

East and South-East.—Lots 277, 138, 137, 136, 1104, 1105, 1100, 1198, 1099, 1171, 1172, 1173, 1174, 1115, 1103, 953, 1101, 1102, 1176, 1177 and 1178 to the Jalan Tanjong Laboh, thence the road to lot No. 485, thence the northern boundary of that lot and lots 505 and 214 to the Sungei Ayam, thence that stream downstream (excluding mining lot C. L. R. 193/22) for about one mile.

South-West and West.—From the Sungei Ayam lines encircling Gunong Patah Pedang to the southern extremity of C. L. R. 189/22, thence that lot and lots 99 and 179 to the service road, thence that road to the Jalan Minyak Beku.

North-West.—The Jalan Minyak Beku to a point opposite the western extremity of lot 427, thence a line and the southern boundary of that lot and Nos. 380, 69, 88, 69, 380 and 181 to its northern extremity, thence a line to the southern extremity of lot 31.

ACCEPTANCE OF SPECIFICATION.

No. 393.—In pursuance of section 7 of The Inventions Enactment, 1911, it is hereby notified that the specification of an invention for "Device for protecting the tap surface of rubber and other trees against rain" has been lodged by Herman Carel Westendorp, of Kroewoek, (Kediri) Isle of Java, Dutch East Indies, a Dutch Subject, and has been accepted by the State Secretary.

The petition of the said Herman Carel Westendorp, of Kroewoek, (Kediri) Isle of Java, Dutch East Indies, a Dutch Subject, for the grant of exclusive privileges in respect of the said invention, together with the said specification, is open to public inspection at the Office of the State Secretary at Johore Bahru.

It is further notified that the said petition will be taken into consideration by His Highness the Sultan in Council at a meeting of the said Council to be held not earlier than two months from the date of the *Gazette* in which this Notification is published; any person interested in opposing the prayer of the petition may serve on the State Secretary a notice, on a paper bearing a stamp of the value of one dollar, of his intention to oppose, and every person so serving a notice will be heard by His Highness the Sultan in Council in opposition to the prayer of the said petition.
