

THE FOREST ENACTMENT (No. 58).

JELUTONG.

No. 56.—For the purpose of assessment of royalty during the months of January to March, 1952, the value of Jelutong will be taken as \$125/- per pikul. [S.S.J. 385/48; C.F. J. 129/45.]

EXTENSION TO SUNGEI JOHORE FOREST RESERVE.

No. 57.—In exercise of the powers conferred upon him by section 3 of the Forest Enactment, and in pursuance of section 12 thereof, the State Secretary, with the approval of His Highness the Sultan in Council, constitutes and declares the land described below and delineated upon registered plan No. G. 7-51 in the office of the Chief Surveyor, Johore, copies of which are deposited in the State Forest Office, a reserved forest in extension and forming part of the Sungei Johore forest reserve.

DESCRIPTION.

SCHEDULE A.

Boundary:—

East:—Commencing at the easternmost corner of lot 974, the boundary runs due East to the right bank of Sungei Johore; thence along this bank, down-stream, to a point due East of the northernmost corner of lot 2; and thence due West to the aforesaid lot corner.

West:—Between the last mentioned point and the point of commencement the reservation is bounded by lots 1, 1040, 50, 83, 450, 310, 1140, 718, 281, and 974, except that between a survey mark on the northern boundary of lot 1140 and the easternmost corner of lot 282, the boundary runs across the Sungei Layang on a bearing of 341 degrees for a distance of 2198 links.

- Note*:—1. Lots 89-93 and 1026, falling within the above described area are hereby excluded from this reserve.
2. All the lots mentioned above are from the Sungei Tiram Mukim register, except 450, which is from the Kota Tinggi District Series.

SCHEDULE B.

Boundary:—

East:—Commencing at the southeastern corner of lot 46, the boundary of the reservation runs due East to the right bank of Sungei Kong Kong; thence down-stream along the right banks of Sungei Kong Kong and Sungei Johore to Kuala Sungei Tiga; thence, up-stream, along the left bank of Sungei Tiga to a point due North of the north-western corner of lot 46; and thence due South to the last mentioned corner.

South and West:—Beyond the last mentioned point the reservation is bounded by lots 46, 331 and 319 as far as its westernmost corner.

Boundary:—

North and East:—Commencing at the southwestern corner of lot 303, the reservation is bounded by contiguous lots 303, 304, 305, 307, 308, 310, 312, 313, 344, 343, 342, 339, 458, 338, 335, 334, 333 and 361 to a survey mark numbered 85/987 on the last mentioned lot. Beyond this point the boundary runs on a bearing of 13 degrees 16 minutes for a distance of 533.36 links to the westernmost corner of lot 358, beyond which the reservation is bounded by contiguous lots 358, 359, 360, 414, 468, 1042, 518, 107, 432, 268, 433, 447, 452 and 465. SCHEDULE D.

Boundary:—Commencing at the westernmost corner of lot 1, the reservation is bounded on the East and North by lots 1, 250, 462, 464, 235, 234, 233, 134, 131, 129, 442, 128, 130, 133, 141, 142, 146, 464 and 465 in that order as far as the southernmost corner of lot 465. Two islands known as Pulau Layang and Pulau Juling situated in Sungei Johore are also included in this reserve. [S.S. 100/49.]

EXTENSION TO PULAI FOREST RESERVE.

No. 58. —In exercise of the powers conferred upon him by section 3 of the Forest Enactment, and in pursuance of section 12 thereof, the State Secretary, with the approval of His Highness the Sultan in Council, constitutes and declares the land described below and delineated upon registered Plan No. G. 10-51 in the office of the Chief Surveyor, Johore, copies of which are deposited in the State Forest Office, a reserved forest in extension and forming part of the Sungei Pulai Forest Reserve.

DESCRIPTION.

District—Pontian. *Mukims*—Tanjong Kupang and Jeram Batu. *Approximate area*—500 acres, as described in the Schedule A. 340 acres, as described in Schedule B. 2,060 acres, as described in Schedule C.

Total=2,900 acres.

SCHEDULE A.

Boundary:—

Commencing at the easternmost corner of lot 948, this reservation is bounded on the North and East by a road reserve, and then by lots 952, 2532, 1712, 264, 262, 261, 715, 2688, 2687, 402, 403, 2331, 412 to 416, 2334 and 2333; and on the South and West by the Sungei Pulai Forest reserve as gazetted under the Johore Government Gazette Notification No. 497 of 24th October, 1923.

Note:—All the lots mentioned above are from the Jeram Batu Mukim register except 715, 948 and 952, which are from the Pontian District Series.

SCHEDULE B.

Boundary:—

North:—Commencing at the southwestern corner of lot 306, the reservation is bounded by lots 306, 305, 2513, 302, 2515 and 299 to 294, and then a straight line between the easternmost corner of lot 294 and the southernmost corner of lot 321; thence by lots 321 to 310, 223, 309, to 307, as far as the easternmost corner of the last mentioned lot; the boundary then runs across Jalan Jeram Batu and along the southeastern boundary of lot 401 as far as the Sungei Pulai Forest reserve as gazetted under the Johore Government Gazette Notification No. 497 of 24th October, 1923.

East, South and West:—Between lot 401 and the commencing point the reservation is bounded in succession by the aforesaid Forest Reserve and lot 715.

Note:—All the lots mentioned above are from the Jeram Batu Mukim register except lot 715 which is from the Pontian District Series.

North, East and South:—Commencing at the southwestern corner of lot 2094, Mukim of Jeram Batu, the reservation is bounded by lots 2094 to 2097, 542 to 537 and 534, Mukim of Jeram Batu, 682, District of Pontian, 2492, Mukim of Jeram Batu, 834 and 461, District of Pontian, 2621, District of Johore Bahru, 2251, 2253, 2255, 2257, 2259, 2305, 2191, 2180, 2179, 2167, 2168, 2166, 2165, 2163 and 2162, Mukim of Jeram Batu, 787, 785 and 784, Mukim of Pulai, and the intervening access reserves; then by the Gelang Patah—Tanjong Kupang road reserve; and then again by lots 1332, 1336, 1337, 1339, 1340, 1338, 1329, 1508 and 1501, Mukim of Tanjong Kupang, and 172, District of Pontian, to the northernmost corner of the last mentioned lot.

West:—Beyond the last reached point the boundary runs due North to the right bank of the Sungei Tarek; thence down-stream following in succession the aforesaid bank and the left bank of Sungei Gelang Patah to the left bank of the Sungei Pulai, thence cutting across the Sungei Pulai to the southeastern corner of the Extension to the Sungei Pulai Forest reserve (G. N. No. 616 of 3rd July, 1935); thence northerly along the eastern boundary of the aforesaid Extension Reserve to its easternmost corner; and thence in a straight line to the point of commencement.
