

THE FOREST ENACTMENT (No. 58)—(cont.).

No. 897.—In exercise of the powers conferred upon him by section 3 of the Forest Enactment and in pursuance of section 12 thereof, the State Secretary, with the approval of His Highness the Sultan in Council, constitutes and declares the land described in the Schedule below and delineated upon registered plan No. G. 5—51 in the office of the Chief Surveyor, Johore, copies of which are deposited in the State Forest Office, a reserved forest, to be known as the Ulu Sedili Forest Reserve.

SCHEDULE.

Districts ..	Mersing and Kota Tinggi.
Mukims ..	Lenggor, Ulu Sungei Sedili Besar and Ulu Sungei Johore.
Approximate Area ..	77,000 acres.

Boundary:

North:—From the mouth of an unnamed tributary of the Sungei Lenggor, a cut line bearing 52° 30', length 130 chains to the westernmost corner of lot 54, Mukim of Lenggor, thence lots 54, 50, 456 and 55, Mukim of Lenggor, to the northernmost corner of lot 50 and then a cut line bearing 52° 30', length 85 chains.

East:—Thence a cut line bearing 150° 00', length 384 chains to Bukit Batu Hijau. Thence a cut line bearing 223° 00', length 200 chains to the north-western corner of lot 40. Thence a cut line bearing 188° 30', length 80 chains to the northwestern corner of lot 51 and thence the western boundaries of lots 51 and 56 to the southernmost corner of the last mentioned lot. Thence cut lines bearing 148° 00', length 64 chains and bearing 169° 30', length 380 chains to the Sungei Ulu Sedili where a tributary from the left meets it. Thence a cut line bearing 137° 00', length 554 chains to a point on a tributary of the Sungei Berasau. Thence cut lines bearing 193° 00', length 80 chains and bearing 211° 00', length 202 chains to Kuala Sikat on the Sg. Dohol. Thence a cut line due south, length 146 chains, to the Panti forest reserve.

South:—The northern boundary of the Panti forest reserve (G. N. No. 727 of 15.9.49) along the Sungei Susur Rotan upstream, and then cut lines as follows:—

to a point on the eastern boundary of lot 181, Mukim of Ulu Sungei Johore; thence lots 181 and 344, Mukim of Ulu Sungei Johore, to a point on the western boundary of lot 344, 21 chains south of its northwestern corner; thence cut lines bearing 272° 00', length 124 chains and bearing 333° 30', length 470 chains to the Sungei Linggui.

West:—The Kluang (G. N. Nos. 269 of 5.3.41 and 420 of 7.6.33) and Lenggor (G. N. No. 524 of 14.5.41) Forest Reserve as far as to the starting point.

Notes:—Lots 636, 44 and 52, Mukim of Lenggor, and lots 154 and 155 (mining certificate No. 458), Mukim of Ulu Sungei Johore, are excluded from this reserve.
