PROPOSED JEMENTAH FOREST RESERVE.

No. 954.—In pursuance of section 4 of the Forest Enactment the State Secretary hereby declares that it is proposed to constitute the land described in the Schedule hereto a reserved forest to be known as the Jementah forest reserve.

SCHEDULE.

District—Segamat. *Mukims*—Gemas and Jementah. *Area*—13,000 acres (approx.)
