THE LAND ACQUISITION ORDINANCE

Cap. 69

DIRECTION UNDER SECTION 5

Whereas it appears to the Yang di-Pertua Negeri that the land referred to in *Gazette* Notification No. 78/2007 should be acquired, but that until surveying work is completed, it is not possible to make an immediate declaration to that effect; now, therefore, in Cap. 69 exercise of the powers conferred upon him by section 5 of the Land Acquisition Ordinance, the Yang di-Pertua Negeri hereby directs that the authorised officers may do any works on the land connected with the use, to which the land is intended to be put on its acquisition, to wit, the Upgrading of the Hot Spring - Tiku Road, Tawau to which the land is intended to be put on its acquisition.
