THE FORESTS ORDINANCE

THE RETUS PROTECTED FOREST (6TH EXCISION) NOTIFICATION, 2015

(Made under section 39)

In exercise of the powers conferred by section 39 of the Forests Ordinance [*Cap. 126 (1958Ed.)*], the Minister for Resource Planning and Environment has made the following Notification:

1. This Notification may be cited as the Retus Protected Forests (6th Excision) Notification, 2015.
2. It is hereby directed that area of land described in the Schedule below, being part of Retus Protected Forest shall cease to be a Protected Forest with effect from 27th February, 2014.
3. All subsisting rights, privileges and special conditions cited in the second schedule of *Gazette* Notification No. 588 published in the Sarawak Government *Gazette* dated 1st May, 1958 in the said area of land shall deemed extinguished.
4. Any persons affected by the extinguishment of his rights or privileges in the area of the land must submit his claim for compensation in respect thereof, together with evidence in the support of such claims to the Regional Forest Officer Sibiu within thirty (30) days from the date of publication of this Notification.

ULU TRUSAN PROTECTED FOREST NOTIFICATION, 2015

[Made under section 26(1)]

Pursuant to section 26(1) of the Forests Ordinance, 1958 [*Cap. 126*], the Minister for Resource Planning and Environment has made the following Notification:

1. This Notification may be cited as the Ulu Trusan Protected Forest, 2015.
2. The area intended to be constituted as the Ulu Trusan Protected Forest is described in the First Schedule and to be known as the "Ulu Trusan Protected Forest".
3. Any person who have any rights or privileges in or over the land described in the First Schedule are required to submit their claims in writing or in person to the Regional Forests Officer, Regional Forests Office, Miri within sixty (60) days from the date of publication of this Notification, together with evidence in support of such claims.

Upon the expiry of the period of sixty (60) days from the date of publication of this Notification, no claim to any rights or privileges in or over the area intended to be constituted a Protected Forest shall be entertained and such rights or privileges, if any, shall be deemed to have been abandoned or the exercise thereof has been waived, by any person entitled thereto.
