THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 110) 2014 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 110) 2014 Direction, and shall come into force on the 25th day of November, 2014.

2. All that area of land situated at Sungai Ragie, Mukah known as Lot 279 Block 107 Oya-Dalat Land District, containing an area of approximately 79.6 square metres, as more particularly delineated on the plan (Print No. 28/AQ/10D/14/2013) and edged thereon in red, is required for public purposes, namely for construction of bridge (Bridge Over Sungai Ragie, Kampung Sungai Ud Road, Mukah – Missed Out Lot). Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
