**THE FORESTS ORDINANCE**

**THE BOK-TISAM PROTECTED FOREST (10TH EXCISION) NOTIFICATION, 2015**

(Made under section 39)

In exercise of the powers conferred by section 39 of the Forests Ordinance [*Cap. 26*], the Minister for Resource Planning and Environment has made the following Notification:

1. This Notification may be cited as the Bok-Tisam Protected Forest (10th Excision) Notification, 2015.

2. It is hereby directed that the area of land described in the Schedule below, being part of Bok-Tisam Protected Forest as constituted under *Gazette* Notification No. 512 published in the Sarawak Government *Gazette* dated 1st May, 1951, shall cease to be a Protected Forest with effect from 27th February, 2014.

3. Any person affected by the extinguishment of his rights or privileges in the said area of land must submit his claims for compensation in respect thereof, together with evidence in the support of such claims, to the Regional Forest Officer, Miri, within thirty (30) days from the date of publication of this Notification.
