THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 1) 2015 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 1) 2015 Direction, and shall come into force on the 10th day of March, 2015.

2. All those areas of land situated at Sungai Matani and Kampung Tengah Pusa, Betong known as Plot A, Plot B and Plot C, containing a total area of approximately 1117.2 square metres, as more particularly delineated on the plan (Print No. 3B/AQ/11D/11/2014) and edged thereon in red, are required for public purposes, namely for the construction of R.C. THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 2) 2015 DIRECTION

(Made under section 5(3) and (4))
