THE FORESTS ORDINANCE, 1958

TRUSAN KELALAN PROTECTED FOREST NOTIFICATION, 2015

(Made under section 26(1))

Pursuant to section 26(1) of the Forests Ordinance, 1958 (*Cap. 126*), the Minister for Resource Planning and Environment has made the following Notification:

1. This Notification may be cited as the Trusan Kelalan Protected Forests, 2015.
2. The area intended to be constituted as the Trusan Kelalan Protected Forest is described in the *First Schedule* and to be known as the “Trusan Kelalan Protected Forest”.
3. Any person who have any rights or privileges in or over the land described in the *First Schedule* are required to submit their claims in writing or in person to the Regional Forests Officer, Regional Forests Office, Miri within sixty (60) days from the date of publication of Notification, together with evidence in support of such claims.
4. Upon the expiry of the above date, no claim to any rights or privileges in or over the area intended to be constituted a Protected Forest shall be entertained and such rights or privileges, if any, shall be deemed to have been abandoned or the exercise thereof has been waived, by any person entitled thereto.
