THE GOVERNMENT RESERVE (CESSATION) (No. 1) NOTIFICATION, 2015

(Made under section 7(2))

In exercise of the powers conferred upon the Director of Lands and Surveys by section 7(2) of the Land Code [*Cap. 81(1958 Ed.)*], the following Notification has been made:

1. This Notification may be cited as the Government Reserve (Cessation) (No. 1) Notification, 2015, and shall come into force on 25th day of April, 2013.
2. The area of State land described in the Schedule and constituted a Government Reserve by *Gazette* Notification No. 1177 dated 16th day of March, 1989, has been declared to be no longer required as Government Reserve.
3. *Gazette* Notification No. 1177 dated 16th day of March, 1989 is hereby revoked.
