THE GOVERNMENT RESERVE (CESSATION) (No. 2) NOTIFICATION, 2015

(Made under section 7(2))

In exercise of the powers conferred upon the Director of Lands and Surveys by section 7(2) of the Land Code [*Cap. 81(1958 Ed.)*], the following Notification has been made:

1. This Notification may be cited as the Government Reserve (Cessation) (No. 2) Notification, 2015, and shall come into force on 23rd day of April, 2015.
