### THE LAND CODE

THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 47) 2015 DIRECTION (Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [Cap. 81], the Minister of Resource Planning and Environment has made the following direction:

- 1. This Direction may be cited as the Land (Native Customary Rights) (No. 47) 2015 Direction, and shall come into force on the 31st day of July, 2015.
- 2. All those areas of land situated along Batang Rajang, Song, Kapit known as part of Lot 144, part of Lot 141, part of Lot 138, part of Lot 136, part of Lot 132, part of Lot 129, part of Lot 122, part of Lot 118 all in Block 11 Katibas Land District and Plot A, containing a total area of approximately 1.2 hectares, as more particularly delineated on the Plan Print No. (78B/AQ/7D/18/2012) and edged thereon in red, are required for public purposes, namely for construction of road [Jalan Poi/Ngemah/Temelat/Song, Kapit Seksyen B (pengambilan tanah tambahan)]. Further details regarding the land can be obtained from the office of the Superintendent of Lands and Surveys, Kapit Division, Kapit.
- 3. As the aforesaid land are required by the Government, the Government has to acquire them. In consequence thereof, all native customary rights over such land shall be taken over by the Government subject to the payment of compensation under section 5(3) of the Land Code.
- 4. As from the date of coming into force of this Direction, all native customary rights over the said land shall cease to subsist and the said land shall revert back to the Government for the aforesaid public purpose.
- 5. Any person having any lawful claim to native customary rights over the said land or any part thereof and whose rights are affected by this Direction shall within sixty (60) days from the date of publication of this Direction in a newspaper circulated in Sarawak, submit his claim, together with evidence in support thereof, to the Superintendent, Lands and Surveys Department, Kapit Division, Kapit in a form prescribed by the Superintendent and obtainable from his office in the said Department. Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.

Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
