THE MALUDAM NATIONAL PARK (EXTENSION I) NOTIFICATION, 2013

(Made under section 10)(1))

Pursuant to section 10)(1) of the National Parks and Nature Reserves Ordinance, 1998 [*Cap. 27*], the Minister for Resource Planning and Environment has made the following Notification:

Citation and Commencement

1. This Notification may be cited as the Maludam National Park (Extension I) Notification, 2013.

Notification

2. The area intended to be constituted as Maludam National Park (Extension I) is described in the *First* Schedule and to be known as the Maludam National Park (Extension I).

3. Any person who has any interest or any right or privileges over the land described in the First Schedule is required to submit their claim in writing or in person to the Chief Park Warden, Kuching Regional Forest Office, within sixty days (60 days) from the date of publication of the Notification, together with evidence in support of such claims.

4. Upon the expiry of the period of sixty (60) days from the date of publication of this Notification, no claim to any right or privileges in or over the area intended to be constituted a national park shall be entertained and such right or privileges, if any, shall be deemed to have been abandoned or the exercise thereof has been waived by any person entitled thereto.
