(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 109) 2015 Direction, and shall come into force on the 1st day of December, 2015.

2. All those areas of land situated from Batang Skrang to Sungai Awik Bridge (along Engkilili/Saratok/Jakar Road) known as Plot 1 until Plot 49, Part of Lots 1, 2, 3, 9, 10, 11, 20, 55, 57, 58, 59, 60, 61, 62, 63, 64, 65, 84, 135, 147, 162, 163, 246, 247 and 248 all in Block 1, Part of Lot 2 Block 2, Part of Lot 47 Block 5 all in Entaban Land District, Part of Lot 925, 926 and 929 all in Block 5, Part of Lot 496 Block 10 all in Batu Api Land District, Part of Lot 860 Blok 4 Paku Land District, Part of Lot 359, 7, 375, 379, 371 all in Block 2 Rimbas Land District dan Part of Lot 7 Block 22 Awik-Krian Land District, containing a total area of approximately 46.1853 hectares, as more particularly delineated on the plans Print No. (2H-2M/AQ/11D/21/2015) and edged thereon in red, are required for public purposes, namely for Proposed Development and Upgrading of Pan Borneo Highway in the State of Sarawak – Batang Skrang to Sungai Awik, Betong. Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
