#### THE LAND CODE

GOVERNMENT OFFICERS EMPOWERED TO ARREST WITHOUT WARRANT

(Made under section 209A)

In exercise of the powers conferred by section 209A(1) of the Land Code [(Cap. 81 (1958 Ed.)], the Director of Lands and Surveys hereby empowers the Superintendents of Lands and Surveys, Kuching, Sri Aman, Sibu, Miri, Limbang, Sarikei, Kapit, Samarahan, Bintulu, Mukah, Betong and Serian Divisions and officers named in the Schedule below to arrest without warrant any person or persons committing or attempting to commit or abetting the commission of an offence under section 32A or 209 of the Land Code.

2. This Notification shall come into force on the 18th day of February, 2016.
