THE NATIONAL PARKS AND NATURE RESERVES ORDINANCE, 1998

BUKIT SARANG NATIONAL PARK NOTIFICATION, 2013

(Made under section 10)

Pursuant to subsection (I) of section 10 of the National Parks and Nature Reserves Ordinance, 1998, the Minister has made the following Notification:

**Citation and Commencement**

1. This Notification may be cited as the Bukit Sarang National Park Notification, 2013.

**Notification**

2. The area intended to be constituted as a National Park is described in the Schedule and to be known as the Bukit Sarang National Park.

3. Any person who has any interest or any any right or privileges over the land described in the Schedule, is required to submit their claim in writing or in person to the Chief Park Warden, Bintulu Regional Office, within sixty days (60 days) from the date of publication of the Notification, together with evidence in support of such claims.

4. Upon the expiry of these period of sixty (60) days from the date of publication of this Notification, no claim to any right or privileges in or over the area intended to be constituted a national park shall be entertained and such right or privileges, if any, shall be deemed to have been abandoned or the exercise thereof has been waived, by any person entitled thereto.
