THE NAKAN-KELULONG FOREST RESERVE (2ND EXCISION) NOTIFICATION, 2012

(Made under section 24)

In exercise of the powers conferred by section 24 of the Forests Ordinance (*Cap. 126 (1958 Ed.)*], the Minister for Resource Planning and Environment has made the following Notification:

1. This Notification may be cited as the Nakan-Kelulong Forest Reserve (2nd Excision) Notification, 2012.

2. It is hereby directed that the area of land described in the Schedule below, being part of the Nakan-Kelulong Forest Reserve as constituted under *Gazette* Notification No. 3417 published in the Sarawak Government *Gazette* Part V, Vol. XXXIX dated 25th October, 1984, shall cease to be a Forest Reserve with effect from 8th August, 2011

Area : 4,824 hectares approximately.

Boundary : Commencing at a point on the existing Nakan-Kelulong Forest Reserve boundary with grid reference (East 2519282.37; North 5371057.09), the boundary follows the existing demarcated Nakan-Kelulong Forest Reserve boundary towards bearing 350° 10' for a distance of 3,648 metres; thence follows a series of cut lines bearing 3° 03' for 1,176 metres; 45° 50' for 580 metres; 68° 00' for 1,670 metres to reach the boundary of Nakan-Kelulong Forest Reserve (1st Excision); thence follows the Nakan-Kelulong Forest Reserve (1st Excision) boundary towards 171° 15' for 1,351 metres; 130° 30' for 4,320 metres to reach the true left bank of Sungai Nakan; thence crosses Sungai Nakan and follows towards downstream for 8,046 metres; thence follows a series of cut lines bearing 121° 57' for 6,769 metres; 186° 01' for 1,141 metres; 275° 30' for 13,744 metres to come back to the point of commencement.
