| Citation | 1. These Rules may be cited as the High Court (Sabah and Sarawak) (Vacation) Rules, 2013. |
| | 2. The High Court in Sabah and Sarawak will be on vacation during the following periods in 2013:

(i) Monday, 3rd June to Friday, 14th June, 2013 (both dates inclusive);

(ii) Monday, 16th December, 2013 to Monday, 31st December, 2013 (both dates inclusive). |
| Public Business | 3. During the vacation the Registries of the High Court will be opened for public business from 9.00 a.m to 12.00 noon on working days. |
| Act of Judge or Officer of High Court | 4. Every act done by any Judge or Officer of the High Court or any party during the vacation shall be effective as if done in term. |
| Vacation not to operate to extend time | 5. The vacation shall not operate to extend time for the doing of any act in the High Court. |
| Summons or other proceedings filed during or prior to vacation | 6. Any summons or other proceedings filed during or prior to the said vacation and required to be laid before a Judge of the High Court during the said vacation shall be accompanied by a Certificate of Urgency signed by an Advocate, and shall thereupon be examined by the Registrar of the High Court who, if satisfied that the matter is urgent, shall cause the proceedings to be submitted to a Judge for his direction. |

Provided that when the parties are in person, or if for other sufficient cause no such Certificate of Urgency can be provided, the Registrar may in his discretion dispense therewith.

THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 10) 2013 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 10) 2013 Direction, and shall come into force on the 1st day of February, 2013.

2. All those areas of land situated at Debak, Betong known as Lot 932, Lot 1049 and Lot 1052 all in Debak Town District, containing a total area of approximately 213.4 square metres, as more particularly delineated on the Plan (Print No. 37B/11D(V3/2009)) and edged thereon in red, are required for public purposes, namely for the development of Flood Mitigation (Flood Mitigation at Debak, Betong (Missed Out Lots)). Further details regarding the land can be obtained from the office of the Superintendent of Lands and Surveys, Betong Division, Betong.

Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
