NATIONAL PARKS AND NATURE RESERVES ORDINANCE, 1998

Pulau Tun Ahmad Zaidi Nature reserve Notification, 2012

(Made under section 10(1))

Pursuant to section 10(1) of the National Parks and Nature Reserves Ordinance, 1998 *[Cap. 27]*, the Minister for Resource Planning and Environment has made the following Notification:

1. This Notification may be cited as the Pulau Tun Ahmad Zaidi Nature Reserve Notification, 2012.

2. The area intended to be constituted as a Nature Reserve is described in the Schedule and to be known as the Pulau Tun Ahmad Zaidi Nature Reserve.

3. Any person claiming any rights or privileges in or over the described area the Schedule is required to submit their claim in writing or in person to the Chief Park Warden, Sibu Region, within sixty (60) days from the date of publication of the Notification, together with evidence in support of such claims.

4. Upon expiry of sixty (60) days from the date of publication of this Notification, no claim to any rights or privileges in or over the area intended to be constituted as nature reserve shall be entertained and such rights and privileges, if any, shall be deemed to have been abandoned or the exercise thereof has been waived, by any person entitled thereto.

THE GUNUNG MULU NATIONAL PARK (EXTENSION I) NOTIFICATION, 2012

(Made under section 19)

In exercise of the power conferred by section 19 of the National Parks and Nature Reserves Ordinance, 1998 *[Cap. 27]*, the Minister, with the approval of the Majlis Mesyuarat Kerajaan Negeri, has made the following Notification:

Citation

 This Notification may be cited as the Gunung Mulu National Park (Extension I) Notification, 2012.

Constitution of a National Park

2. The land described in the First Schedule shall, with effect from 15th day of December, 2011, be constituted as National Park which is to be known as the Gunung Mulu National Park (Extension I) (in this Notification referred to as "the National Park").

Prohibited Activities

3. Subject to section 21 and 26 of the National Parks and Nature Reserves Ordinance, 1998 *[Cap. 27]*, no person other than a person acting under and in accordance with the permission of the Controller, shall:

12th April, 2012]

- (a) enter, reside or remain in the National Park;
- (b) convey or possess any weapon, explosive, trap or poison or any contrivance of any kind used for the taking, capturing, shooting, killing or destroying of any animals;
- (c) kill, injure, capture, or disturb any animal or take or destroy any plant, egg or nest;
- (d) cut or set fire to any vegetation or damage any object of geological, prehistorical, archaeological, historical or other scientific interest;
- (e) introduce any animal or permit any domestic animal to stray or introduce any plant;
- (f) remove any animal or plant whether dead or alive, other than any animal or plant lawfully introduced by the person removing it;
- (g) remove any object of geological, prehistoric, archaeological, historical or other scientific interest;
- (h) destroy or deface any object whether animate or inanimate;
- (*i*) erect any building in the National Park;
- (j) clear or break up any land in the National Park;
- (k) without prejudice to any rights lawfully acquired before 16th February, 1956; and the provision of any law for the time being in force in Sarawak relating to mining, prospect for minerals in the National Park; and
- (*l*) place, dump, deposit, leave or throw any carcass, paper, boxes, bottles, tins, refuse of any kind, noxious liquid or other filthy matter of any kind in the National Park.

Privileges of local inhabitants

4. Notwithstanding *paragraph* 3, the inhabitants of the areas and villages (kampongs) mentioned in the *Second Schedule* shall have the privileges to enter the National Park to collect minor forest produce for their own consumption, but not for sale or profit.

SECOND SCHEDULE

(Paragraph 4)

The semi-nomadic Penan Community, the inhabitants of Long Meraan/Long Kidah, Pa'Ubong, Long Siyang, Pa'Puak, Pa'Tepan, Long Balau, Long Lesuan and Kpg. Batu Bungan and Nomadic Penans living within the National Park, shall have the rights or privileges to:

- (i) hunt non-protected wildlife species in the National Park for own consumption but not for sale, barter or profit and it shall be an offence to hunt the protected wildlife species as listed in the *First* and *Second Schedule* of the Wild Life Protection Ordinance, 1998 [*Cap.* 26];
- (ii) collect from the National Park the following forest produce:
 - Damar;
 - Rattan;
 - Rubber, including jelutong, getah rian and malau;
 - Pandan leaves, and leaves of other plants, for basket making and weaving;
 - · Edible plants or parts thereof, including fruits, leaves and roots; and
- (iii) take fish from rivers and tributaries, using traditional traps and fishing methods, within the National Park.

BUKIT LIMA NATURE RESERVE NOTIFICATION, 2012

(Made under section 20(1))

Pursuant to section 20(1) of the National Parks and Nature Reserves Ordinance, 1998 *[Cap. 27]*, the Minister with the approval of the Majlis Mesyuarat Kerajaan Negeri, has made the following Notification:

1. This Notification may be cited as the Bukit Lima Nature Reserve Notification, 2012.

2. The area described in the Schedule and to be known as Bukit Lima Nature Reserve is constituted as a Nature Reserve with effect from 15th December, 2011.

3. The Bukit Lima Nature Reserve and the special area declared under Public Parks and Greens Ordinance, 1993 (*Cap. 3*) shall cease to be a Forest Reserve and Parks and Greens upon the date of coming into effect of this Notification.

4. Upon the constitution of the Nature Reserve, no person, other than a person acting under and in accordance with the permission of the Controller, shall:

- (a) enter, reside or remain in the nature reserve;
- (b) convey into, or possess any weapon, explosive, trap or poison or any contrivance of any kind used for the taking, capturing, shooting, killing or destroying of any animals in the nature reserve;
- (c) within the nature reserve, kill, injure, capture, or disturb any animal or take or destroy any plant, egg or nest;
- (d) cut or set fire to any vegetation or damage any object of geological, prehistorical, archaeological, historical or other scientific interest;
- (e) introduce any animal or permit any domestic animal to stray, or introduce any plant in the nature reserve;
- (f) remove from the nature reserve any animal or plant whether alive or dead other than animal or plant lawfully introduced by the person removing it;
- (g) remove from the nature reserve any object of geological, prehistoric, archaeological, historical or other scientific interest;
- (*h*) destroy or deface any object whether animate or inanimate in the nature reserve;
- (i) erect any building in the nature reserve;
- (j) clear or break up any land in the nature reserve;

- (k) prospect for mining of minerals, without prejudice to any rights lawfully acquired before 16th February, 1956; and the provision of any law for the time being in force in Sarawak; and
- (*l*) place, dump, deposit, leave or throw any carcass, paper, boxes, bottles, tins, refuse of any kind, noxious liquid or other filthy matter of any kind in the nature reserve.

5. Any person who does any act which is prohibited under paragraph 4 above shall be liable to penalty prescribed in section 32 of National Parks and Nature Reserves Ordinance, 1998.

- (g) remove form the National Park any object of geological, prehistoric, archaeological, historical or other scientific interest;

- (j) clear or break up any land in the National Park;
- (k) prospect for mining of minerals, without prejudice to any rights lawfully acquired before 16th February, 1956; and the provision of any law for the time being in force in Sarawak; and
- (*l*) place, dump, deposit, leave or throw any carcass, paper, boxes, bottles, tins, refuse of any kind, noxious liquid or other filthy matter of any kind in the National Park.
