THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 21) 2016 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 21) 2016 Direction, and shall come into force on the 12th day of February, 2016.

2.
