THE MELANA PROTECTED FOREST (1ST EXTENSION) NOTIFICATION, 2016

[Made under section 8(1)]

Pursuant to section 8(1) of the Forests Ordinance, 2015 [*Cap. 71*], the Minister for Resource Planning and Environment has made the following Notification:

1. This Notification may be cited as the Melana Protected Forest (1st Extension), 2016.
2. The area intended to be constituted as the Melana Protected Forest (1st Extension) is described in the *First Schedule* and to be known as the "Melana Protected Forest (1st Extension)".
