### NATIONAL PARKS AND NATURE RESERVES ORDINANCE, 1998

#### FAIRY CAVE NATURE RESERVE (EXTENSION) NOTIFICATION, 2016

(Made under section 10(1))

Pursuant to section 10(1) of the National Parks and Nature Reserves Ordinance, 1998 [*Cap. 27*], the Minister for Resource Planning and Environment has made the following Notification:

1. This Notification may be cited as the Fairy Cave Nature Reserve (Extension) Notification, 2016.

2. The area intended to be constituted as a nature reserve is described in the First Schedule and to be known as the Fairy Cave Nature Reserve (Extension).

3. Any person who has any interest or any rights or privileges over the land described in the Schedule is required to submit their claims in writing or in person to the Chief Park Warden, Kuching Region, within sixty (60) days from the date of publication of the Notification, together with evidence in support of such claims.

4. Upon the expiry of the period of sixty (60) days from the date of publication of this Notification, no claim to any rights or privileges in or over the area intended to be constituted a nature reserve shall be entertained and such rights or privileges, if any, shall be deemed to have been abandoned or the exercise thereof has been waived, by any person entitled thereto.

#### *SCHEDULE*

Name : Fairy Cave Nature Reserve (Extension).

Division : Kuching.

District : Bau.

Area : 18.02 hectares approximately

NATIONAL PARKS AND NATURE RESERVES ORDINANCE, 1998

KALAMUKU NATIONAL PARK NOTIFICATION, 2016

(Made under section 20)

In exercise of the power conferred by section 20 of the National Parks and Nature Reserves Ordinance, 1998 [*Cap. 27*], the Minister for Resource Planning and Environment, with the approval of the Majlis Mesyuarat Kerajaan Negeri, has made the following Notification:

### **Citation**

1. This Notification may be cited as the Kalamuku National Park Notification, 2016.

### **Constitution of a national park**

2. The land described in the First Schedule shall, with effect from 31st day of March, 2016 be constituted as National Park which is to be known as the Kalamuku National Park (in this Notification referred to as the “the National Park”) and cease to be a forest reserve.

### **Prohibited Activities**

3. Subject to sections 21 and 26 of the National Parks and Nature Reserves Ordinance, 1998 [*Cap. 27*], no person other than a person acting under and in accordance with the permission of the Controller, shall:

- (a) enter, reside or remain in the National Parks;
- (b) convey or possess any weapon, explosive, trap or poison or any Contrivance of any kind used for the taking, capturing, shooting, killing or destroying of any animals;

- (c) kill, injure, capture, or disturb any animal or take or destroy any plant, egg or nest;
- (d) cut or set fire to any vegetation or damage any object of geological, prehistorical, archaeological, historical or other scientific interest;
- (e) introduce any animal or permit any domestic animal to stray or introduce any plant;
- (f) remove any animal or plant whether dead or alive, other than any animal or plant lawfully introduced by the person removing it;
- (g) remove any object of geological, prehistorical, archaeological, historical or other scientific interest;
- (h) destroy or deface any object whether animate or inanimate;
- (i) erect any building in the National Park;
- (j) clear or break up any land in the National Park;
- (k) without prejudice to any rights lawfully acquired before 16th February, 1956; and to the provision of any law for the time being in force in Sarawak relating to mining, prospect for minerals in any National Park; and
- (l) place, dump, deposit, leave or throw any carcass, paper, boxes, bottles, tins, refuse of any kind, noxious liquid or other filthy matter of any kind in the National Park.

### **Privileges of local inhabitants**

4. Notwithstanding *paragraph 3*, the rights or privileges of the inhabitants or person mentioned in the *Second Schedule* shall be limited to such rights or privileges as indicated in the *Second Schedule* thereto. The exercise of these rights or privileges shall be regulated by the Controller of National Parks and Nature Reserves and for this purposes, the Controller may issue direction or notice pertaining to the exercise of these rights or privileges.

## SECOND SCHEDULE

- a. The permanent inhabitants of the Murut houses Rumah Baru Dawat, Rumah Tadam Buaya and Rumah Kiri Bekatam have the rights:
  - i. to take timber and other forest produce for their own domestic use and not for sale or barter, provided that the quantity taken shall be subject to the reasonable control of the Controller of National Parks and Nature Reserves; and
  - ii. to catch fish using traditional method and hunting non protected wildlife for own consumption and not for barter, sale or trade.
- b. Amat Lasong has the right to tap 91 rubber trees and remove fruit from planted fruit within the same area with condition that no more trees shall be planted.
