### THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 32) 2018 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Urban Development and Natural Resources has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 32) 2018 Direction, and shall come into force on the 24th day of May, 2018.

2.
