THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 46) 2013 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 46) 2013 Direction, and shall come into force on the 6th day of August, 2013.

2. All those areas of land situated at Kampung Semeru, Puncak Borneo, Kuching known as Plot A and Plot B, containing a total area of approximately 554.4 square metres, as more particularly delineated on the plan (Print No. 3/AQ/1D/22/2013) and edged thereon in red, are required for public purposes, namely for construction of a water supply system (“Bekalan Air Luar Bandar (BALB) di Kampung Semeru, Puncak Borneo, Kuching”). Further details regarding the land can be obtained from the office of the Superintendent of Lands and Surveys, Kuching Division, Kuching.

3. As the aforesaid land are required by the Government, the Government has to acquire them In consequence thereof, all native customary rights over such land shall be taken over by the Government subject to the payment of compensation under section 5(3) of the Land Code.

4. As from the date of coming into force of this Direction, all native customary rights over the said land shall cease to subsist and the said land shall revert back to the Government for the aforesaid public purpose.

Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
