## NATIONAL PARKS AND NATURE RESERVES ORDINANCE, 1998

### LUCONIA SHOALS NATIONAL PARK NOTIFICATION, 2017

(Made under section 10(1))

Pursuant to section 10(1) of the National Park and Nature Reserve Ordinance, 1998 [*Cap. 27*], the Minister has made the following Notification:

1. This Notification may be cited as the Luconia Shoals National Park Notification, 2017.
2. The area intended to be constituted as a National Park is described in the Schedule and to be known as the Luconia Shoals National Park.
3. Any person claiming any right or privileges over the area described in the Schedule is required to submit his claim in writing or in person to the Chief Park Warden, Miri Region, within sixty (60) days from the date of publication of this Notification, together with evidence in support of such claims.
4. Upon the expiry of the period of sixty (60) days from the date of publication of this Notification, no claim to any right or privileges in or over the area intended to be constituted as a National Park shall be entertained and such right or privileges, if any, shall be deemed to have been abandoned or the exercise thereof has been waived, by any person entitle thereto.

Locality : Sarawak Territorial Water North of Miri Shoreline  
Area : 1,011,772 hectares approximately

#### Boundaries description:

CHARITABLE TRUST DECLARATION, 2017

(Made under section 3)

In exercise of the powers conferred by section 3(1) of the Charitable Trust Ordinance, 1994 [*Cap. 7*], the Yang di-Pertua Negeri has made the following Declaration:

**Citation and commencement**

1. This Declaration may be cited as the Amanah Khairat Masjid Al-Muhajirin Kampung Usahajaya Baru, SibU, Charitable Trust Declaration, 2017 and shall be deemed to have come into force on the 1st day of July, 2017.

**Declaration of Charitable Trust**

2. It is hereby declared that:

- (a) a Charitable Trust shall be created and be known as the Amanah Khairat Masjid Al-Muhajirin Kampung Usahajaya Baru, SibU, Charitable Trust;
- (b) the properties described in the First Schedule shall be administered by a Board of Trustees appointed under section 4 of the Charitable Trusts Ordinance, 1994 [*Cap. 7*];

- (d) the purposes of the Amanah Khairat Masjid Al-Muhajirin Kampung Usahajaya Baru, SibU, Charitable Trust are as set out in the Second Schedule.

Trust Properties

Funds which have been or shall be donated, collected or pledged for the trust purposes stipulated in the Second Schedule.

(Paragraph 2(d))

Trust Purposes

1. The provision of systematic administration to realize community development agenda at Kampung Usahajaya Baru, SibU.

THE LAND CODE

THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 58) 2017 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 58) 2017 Direction, and shall come into force on the 30th day of June, 2017.

2. All that area of land situated at Sungai Sapi, Kampung Gelam, Song known as Plot A, containing an area of approximately 1206.04 square metres, as more particularly delineated on the plan (Print No. 19/AQ/7D/16/2015) and edged thereon in red, is required for a public purpose, namely for “Cadangan Pertapakan Funeral Parlour Pekan Song, Kapit”. Further details regarding the land can be obtained from the office of the Superintendent of Lands and Surveys, Kapit Division, Kapit.

3. As the aforesaid land is required by the Government, the Government has to acquire it. In consequence thereof, all native customary rights over such land shall be taken over by the Government subject to the payment of compensation under section 5(3) of the Land Code.

4. As from the date of coming into force of this Direction, all native customary rights over the said land shall cease to subsist and the said land shall revert back to the Government for the aforesaid public purpose.

5. Any person having any lawful claim to native customary rights over the said land or any part thereof and whose rights are affected by this Direction shall within sixty (60) days from the date of publication of this Direction in a newspaper circulated in Sarawak, submit his claim, together with evidence in support thereof, to the Superintendent, Lands and Surveys Department, Kapit Division, Kapit in a form prescribed by the Superintendent and obtainable from his office in the said Department. Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.

(The abovementioned plan may be inspected at the office of the Superintendent, Lands and Surveys Department, Kapit Division, Kapit, and at the District Office, Song.)

THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 59) 2017 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 59) 2017 Direction, and shall come into force on the 30th day of June, 2017.
