THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 48) 2013 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 48) 2013 Direction, and shall come into force on the 26th day of August, 2013.

2. All those areas of land situated at Kampung Peraya, Padawan, Kuching known as Plot A and Plot B, containing a total area of approximately 387.1 square metres, as more particularly delineated on the Plan (Print No. 22/AQ/1D/26/2012) and edged thereon in red, are required for public purposes, namely for a development of a bridge (Bridge Over Kampung Peraya, Padawan, Kuching - additional lots). Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
