1. This Direction may be cited as the Land (Native Customary Rights) (No. 56) 2013 Direction, and shall come into force on the 12th day of September, 2013.

2. All that area of land situated at Kampung Belimbing, Puncak Borneo, Kuching known as Plot A and Plot B, containing an area of approximately 2624.23 square metres, as more particularly delineated on the Plan (Print No. 4/AQ/1D/25/2013) and edged thereon in red, is required for a public purpose, namely for construction of Rural Water Supply (“Projek Membina dan Menyiapkan Bekalan Air Luar Bandar (BALB) di Kpg. Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
