THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 80) 2016 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 80) 2016 Direction, and shall come into force on the 29th day of August, 2016.

THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 87) 2016 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 87) 2016 Direction, and shall come into force on the 16th day of August, 2016.

2. All that area of land situated at Sungai Bakam, Sungai Rait, Simpang 7, Miri known as Plot A, containing an area of approximately 1856 square metres, as more particularly delineated on the plan (Print No. 3/AQ/4D/15/2016) and edged thereon in red, is required for a public purpose, namely for Proposed Bridge Over Sungai Bakam, Sungai Rait, Simpang 7, Miri. Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
