### THE NATIONAL PARKS AND NATURE RESERVES ORDINANCE, 1998

#### THE BRUIT NATIONAL PARK NOTIFICATION, 2013

(Made under section 19)

In exercise of the powers conferred by section 19 of the National Parks and Nature Reserves Ordinance, 1998 [*Cap. 27*], the Minister for Resource Planning and Environment, with the approval of the Majlis Mesyuarat Kerajaan Negeri, has made the following Notification:

#### Citation

1. This Notification may be cited as the Bruit National Park Notification, 2013.

**Constitution of a National Park**

2. The land described in the *First Schedule* shall, with effect from 22nd day of August, 2013, be constituted as National Park which is to be known as the Bruit National Park (in this Notification referred to as “the National Park”).

**Prohibited Activities**

3. Subject to sections 21 and 26 of the National Parks and Nature Reserves Ordinance, 1998 [*Cap. 27*], no person other than a person acting under and in accordance with the permission of the Controller, shall:

- (a) enter, reside or remain in the National Park;
- (b) convey or possess any weapon, explosive, trap or poison or any contrivance of any kind used for the taking, capturing, shooting, killing or destroying of any animals;
- (c) kill, injure, capture, or disturb any animal or take or destroy any plant, egg or nest;
- (d) cut or set fire to any vegetation or damage any object of geological, prehistorical, archaeological, historical or other scientific interest;
- (e) introduce any animal or permit any domestic animal to stray or introduce any plant;
- (f) remove any animal or plant whether dead or alive, other than any animal or plant lawfully introduced by the person removing it;
- (g) remove any object of geological, prehistoric, archaeological, historical or other scientific interest;
- (h) destroy or deface any object whether animate or inanimate;
- (i) erect any building in the National Park;
- (j) clear or break up any land in the National Park;
- (k) without prejudice to any rights lawfully acquired before 16th February, 1956; and the provision of any law for the time being in force in Sarawak relating to mining, prospect for minerals in the National Park; and
- (l) place, dump, deposit, leave or throw any carcass, paper, boxes, bottles, tins, refuse of any kind, noxious liquid or other filthy matter of any kind in the National Park.

**Privileges of local inhabitants**

4. Notwithstanding *paragraph 3*, the inhabitants of the village or kampung specified in the *Second Schedule* shall have the privileges to enter the National Park to rear cattle on condition that they cannot increase the number of cattle in the area.

## FIRST SCHEDULE

Name : Bruit National Park.  
Division : Mukah.  
District : Daro.  
Area : 1,804 hectares approximately.

Boundaries :

### *Area I (559.7 hectares)*

The entire island of "Pulau Patok", which is also known as Lot 551, Block 2, Bruit Land District as pegged by Land and Survey Department. The entire island of Pulau Patok and the entire island of Pulau Jangau down to low tide mark around them.

### *Area II (1,244.3 hectares)*

Commencing from a point (E 112° 21' 05.86"; N 02° 46' 17.99") at the river mouth of Sungai Beras Besar, the boundary follows the coast line (low tide mark) in a generally North-westerly; thence Westerly; thence South-westerly direction for 7,824 meters to the river mouth of Sungai Lemang Taud; thence follows the true right bank of Sungai Lemang Taud upstream for 2,362 meters; thence follows a series of cut line bearing 60° 30' for 204 metres; 89° 00' for 572 metres; 68° 00' for 632 metres; 115° 00' for 411 metres to reach the old light-house at Kpg. Pelita; thence 115° 00' for 3,040 metres to reach Sungai Beras Besar; thence along the true left bank of Sungai Beras Besar downstream for 750 metres to come back to the point of commencement.

**Note:** Bearings and distances are approximate only and the ground demarcated boundaries and grid reference points shall be considered correct.

### THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 60) 2013 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 60) 2013 Direction, and shall come into force on the 2nd day of October, 2013.

2. All that area of land situated at Ngemah, Kanowit, Sibuhulu known as Plot A and Plot B, containing a total area of approximately 4.1979 hectares, as more particularly delineated on the Plan (Print No. 2A/AQ/3D/10/2013) and edged thereon in red, are required for public purposes, namely for the construction of access road ("Jalan Poi/Ngemah/Temelat/Song, Kapit (Seksyen B), Bahagian Sibuhulu"). Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
