THE FORESTS ORDINANCE

THE BUAN FOREST RESERVE (4TH EXCISION) NOTIFICATION, 2013

(Made under section 24)

In exercise of the powers conferred by section 24 of the Forests Ordinance (*Cap. 126(1958 Ed.)*) the Minister for Resource Planning and Environment has made the following Notification;

Citation and Commencement

1. This Notification may be cited as the Buan Forest Reserve (4th Excision) Notification, 2013.

Notification

2. It is hereby directed that the area of land described in the Schedule below, being part of the Buan Forest Reserve as constituted under *Gazette* Notification No. 809 dated 17th March, 1977, shall cease to be a Forest Reserve with effect from 27th October, 2010.

3. Any person affected by the extinguishment of his rights or privileges in that area of land must submit his claim for compensation in respect thereof, together with evidence in support of such claims, to the Regional Forest Officer, Bintulu, within thirty (30) days from the publication of this Notification.




