### THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 86) 2017 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 86) 2017 Direction, and shall come into force on the 15th day of September, 2017.

2. All those areas of land situated at Batang Seredeng, Batang Loba Satubah dan Batang Loba Stabar, Sarikei known as Plot A, Plot B, Plot C, Plot D and Plot E, containing a total area of approximately 1.0691 hectares, as more particularly delineated on the plan (Print No. 2/AQ/6D/13/2016) and edged thereon in red, are required for a public purposes, namely for Tanjung Manis Water Supply Phase 1 Package 3 – Proposed Jointing Laying, Testing & Commissioning of the 1600mm ND MPSUL Raw Water Pumping Main, Sarikei. Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
