THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 68) 2013 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 68) 2013 Direction, and shall come into force on the 14th day of October, 2013.

2. All those areas of land situated at Nanga Medamit, Limbang known as Plot A and Plot B, containing a total area of approximately 8355.5 square metres, as more particularly delineated on the plan (Print No. 125/5D(V1/2008)) and edged thereon in red, are required for public purposes, namely for the construction of road (Access Road to Limbang Dam – Additional area). Further details regarding the land can be obtained from the office of the Superintendent of Lands and Surveys, Limbang Division, Limbang.

Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
