1. This Direction may be cited as the Land (Native Customary Rights) (No. 63) 2013 Direction, and shall come into force on the 1st day of November, 2013.

2. Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
