THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 2) 2007 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Planning and Resource Management has made the following Direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 2) 2007 Direction, and shall come into force on the 14th day of February, 2007.
2. All that area of land situate at Sungai Melinau, Mulu, Baram, Miri known as Plot A, Plot B and Plot C containing an area of approximately 1,120 square metres, 12,141 square metres and 1,170 square metres respectively, as more particularly delineated on the Plan Print No. MD/20/66565(V) and edged thereon in red, is required for a public purpose, namely, for the SESCO Power Station.
