THE FORESTS ORDINANCE

COMPOUNDING OF OFFENCES

(Section 70(1))

In exercise of the powers conferred by section 70(1) of the Forests Ordinance [*Cap. 126 (1958 Ed.)*], the Director of Forests, Sarawak, empowers the forest officers named in the Schedule to accept from any person who has committed a forest offence:

- (a) in the case of an offence against section 79, 80, 85 or 86, a sum of money not exceeding twice the value (as estimated by the Director or any person authorized by him) of the forest produce in respect of which the offence has been committed; or
- (b) in respect of any other offences, except for section 83(1), punishable under this Ordinance, a sum of money not exceeding two hundred ringgit; or
- (c) in the case of an offence punishable by any rules or orders made under this Ordinance, the actual value (as estimated by the Director or any person authorized by him) of the forest produce in respect of which the offence has been committed,

by way of compensation for the offence committed with effect from the 1st day of April, 2004:

THE FORESTS ORDINANCE

THE SIMILAJAU FOREST RESERVE (36TH EXCISION) NOTIFICATION, 2004

(Made under section 24)

In exercise of the powers conferred by section 24 of the Forests Ordinance [*Cap. 126 (1958Ed.)*], the Minister of Planning and Resource Management has made the following Notification:

1. This Notification may be cited as the Similajau Forest Reserve (36th Excision) Notification, 2004.
2. It is directed the area of land described in the Schedule below, which was constituted as Forest reserve under *Gazette* Notification No. 1461 published on 1st December, 1959 (Similajau Forest Reserve Extension), shall cease to be a forest reserve with effect from 28th day of January, 2004.
3. All subsisting rights, privileges, and special conditions cited in the Second Schedule of *Gazette* Notification No. 1461 published in the Sarawak Government *Gazette* dated 1st December, 1959, in the said area of land shall be deemed extinguished.
4. Any person affected by the extinguishment of his rights or privileges in the said area of land must submit his claim for compensation in respect thereof, together with evidence in the support of such claims, to the Regional Forest Officer, Bintulu, within thirty (30) days from the date of publication of this Notification.

SCHEDULE

Area : 2955 hectares approximately

Boundary : Commencing at a point (N003° 43' 35"; E113° 29' 30") which is at the present Similajau Forest Reserve Extension Boundary, the boundary proceeds along the Sungei Telong upstream for 13 500 metres to meet a bend just below Bukit Raja; thence the boundary follows two cut lines bearing 80° 00' for 14 100 links (2820 metres); 20° 00' for 16 000 links (3200 metres) to meet a point N003° 44' 25"; E113° 32' 36" on the boundary of Farmland [*G.N. No. 1244(iv) dated 22.10.1954*]; thence along this farmland boundary towards North-Westerly direction to reach another point at N003° 45' 52"; E113° 30' 52"; thence follows a series of cut lines bearing 248° 30' for 4000 metres; 143° 30' for 2100 metres and 181° 30' for 980 metres to come back to the point of commencement.

Note: Bearings, distances and the GPS reading are approximate only and the demarcated boundaries shall be considered correct.
