**TEMPORARY ASSIGNMENT OF FUNCTIONS AND RESPONSIBILITIES OF THE
MINISTER OF INFRASTRUCTURE DEVELOPMENT AND COMMUNICATIONS**

It is hereby notified for general information that pursuant to Article 9 of the Constitution of the State of Sarawak, the Yang di-Pertua Negeri, Sarawak, in accordance with the advice of the Chief Minister, has directed that, at any time during the period of absence of Yang Berhormat Datuk Patinggi (DR.) Alfred Jabu anak Numpang, Deputy Chief Minister and Minister of Infrastructure Development and Communications from Sarawak or during his temporary incapacity through illness or for any other cause whatsoever, the functions and responsibilities for the business of the Government of Sarawak and the administration of the Ministry and Departments of the Government which are the responsibilities of the Minister of Infrastructure Development and Communications shall be assigned to and shall be performed and exercisable by Yang Berhormat Dato' Sri Wong Soon Koh, Minister of Environment and Public Health and Minister of Finance II with effect from the 15th day of May, 2009.

THE FORESTS ORDINANCE

MUJONG-MERIRAI PROTECTED FOREST (2ND Extension) NOTIFICATION, 2001

In exercise of the powers conferred on him by section 33 of the Forests Ordinance [*Cap. 126*], (1958 Ed.), the Minister hereby declares that the land enclosed within the boundaries described in the First Schedule hereto a Protected Forest with effect from 1st December, 2000, subject to the rights admitted and specified in the Second Schedule.

SECOND SCHEDULE

The permanent inhabitants of the following longhouses shall have the rights to continue the traditional activities of fishing, hunting and collecting of jungle produce within the area for personal and domestic use only, but it shall be an offence to clear high forest except with the authority of the Director of Forests.
