THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 71) 2013 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 71) 2013 Direction, and shall come into force on the 19th day of December, 2013.

2. All those areas of land situated at Kampung Paloh, Kabong, Betong known as Plot A, Plot B, Plot C, Plot D, Plot E, Plot F, Plot G, Part of Lot 312 Pre-Block and Part of Lot 55 Block 17 Kalaka Land District, containing a total area of approximately 53.59771 hectares, as more particularly delineated on the Plan Print No. 3B/AQ/11D7/2012 and edged thereon in red, are required for public purposes, namely for Controlled Drainage Scheme (Beting Maro Controlled Drainage Scheme, Betong). Further details regarding the land can be obtained from the office of the Superintendent of Lands and Surveys, Betong Division, Betong.

3. As the aforesaid land are required by the Government, the Government has to acquire them. In consequence thereof, all native customary rights over such land shall be taken over by the Government subject to the payment of compensation under section 5(3) of the Land Code.

4. As from the date of coming into force of this Direction, all native customary rights over the said land shall cease to subsist and the said land shall revert back to the Government for the aforesaid public purpose.

5. Any person having any lawful claim to native customary rights over the said land or any part thereof and whose rights are affected by this Direction shall within sixty (60) days from the date of publication of this Direction in a newspaper circulated in Sarawak, submit his claim, together with evidence in support thereof, to the Superintendent, Lands and Surveys Department, Betong Division, Betong in a form prescribed by the Superintendent and obtainable from his office in the said Department. Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
