



THE LAND CODE

THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 81) 2013 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 81) 2013 Direction, and shall come into force on the 6th day of January, 2014.

2. All that area of land situated at Kampung Bintawa Hilir, Petra Jaya, Kuching known as part of Lot 9411 Block 18 Salak Land District, containing an area of approximately 65.7 square metres, as more particularly delineated on the plan (Print No. 29B/1D(V47/2010) and edged thereon in red, is required for a public purpose, namely for construction of a bridge (Bridge over Sungai Haji Kasim (Sungai Kampung Bintawa Hilir), Petra Jaya, Kuching – Additional Land). Further details regarding the land can be obtained from the office of the Superintendent of Lands and Surveys, Kuching Division, Kuching.

3. As the aforesaid land is required by the Government, the Government has to acquire it. In consequence thereof, all native customary rights over such land shall be taken over by the Government subject to the payment of compensation under section 5(3) of the Land Code.

4. As from the date of coming into force of this Direction, all native customary rights over the said land shall cease to subsist and the said land shall revert back to the Government for the aforesaid public purpose.

5. Any person having any lawful claim to native customary rights over the said land or any part thereof and whose rights are affected by this Direction shall within sixty (60) days from the date of publication of this Direction in a newspaper circulated in Sarawak, submit his claim, together with evidence in support thereof, to the Superintendent, Lands and Surveys Department, Kuching Division, Kuching in a form prescribed by the Superintendent and obtainable from his office in the said Department. Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.

(The abovementioned plan may be inspected at the office of the Superintendent Lands and Surveys Department, Kuching Division, Kuching and District Office, Kuching.)

## THE LAND CODE

### THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 83) 2013 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 83) 2013 Direction, and shall come into force on the 6th day of January, 2014.

2. All that area of land situated at Sungai Buei RPR Batu 6, Miri known as Lot 1217 Miri Concession Land District, containing an area of approximately 873 square metres, as more particularly delineated on the plan (Print No. 5A/AQ/4D/26/2013) and edged thereon in red, is required for a public purpose, namely for Muslim Cemetery (Muslim Cemetery Sungai Buei RPR Batu 6, Miri). Further details regarding the land can be obtained from the office of the Superintendent of Lands and Surveys, Miri Division, Miri.

3. As the aforesaid land is required by the Government, the Government has to acquire it. In consequence thereof, all native customary rights over such land shall be taken over by the Government subject to the payment of compensation under section 5(3) of the Land Code.

4. As from the date of coming into force of this Direction, all native customary rights over the said land shall cease to subsist and the said land shall revert back to the Government for the aforesaid public purpose.

5. Any person having any lawful claim to native customary rights over the said land or any part thereof and whose rights are affected by this Direction shall within sixty (60) days from the date of publication of this Direction in a newspaper circulated in Sarawak, submit his claim, together with evidence in support thereof, to the Superintendent, Land and Survey Department, Miri Division, Miri in a form prescribed by the Superintendent and obtainable from his office in the said Department. Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
