THE CONSTITUTION OF THE STATE OF SARAWAK

APPOINTMENT TO ACT AS PERMANENT SECRETARY
TO THE MINISTRY OF INFRASTRUCTURE DEVELOPMENT AND

THE FORESTS ORDINANCE

COMPOUNDING OF OFFENCES

In exercise of the powers conferred by section 70(1) of the Forests Ordinance, 1958 [*Cap. 126(1958 Ed)*], the Director of Forests, Sarawak empowers the following officers named in the Schedule to accept from any person who has committed a forest offence:

- (a) in the case of an offence against section 65(3), 79, 80, 83(3), 85 or 86, a sum of money not exceeding twice the value (as estimated by the Director or any person authorized by him) of the forest produce in respect of which the offence has been committed; or
- (b) in respect of any other offences, except for section 83(1), punishable under the Ordinance, a sum of money not exceeding Two Hundred Ringgit; or
- (c) in the case of an offence punishable by any rules or orders, made under this Ordinance, the actual value (as estimated by the Director or any person authorized by him) of the forest produce in respect of which the offence has been committed,

by way of compensation for the offence committed with effect from the 1st day of April, 2014.

THE LAND CODE

THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 10) 2014 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 10) 2014 Direction, and shall come into force on the 20th day of February, 2014.

2. All that area of land situated at Ulu Sungai Engkabang, Tanjong Assam, Spaoh, Betong known as Plot A, containing an area of approximately 25.4423 hectares, as more particularly delineated on the plan (Print No. 28A/11D(V19)/2011) and edged thereon in red, is required for a public purpose, namely for Service Centre (Tanjung Assam-Sebemban-Balingian Service Centre, Betong - Resiting). Further details regarding the land can be obtained from the office of the Superintendent of Lands and Surveys, Betong Division, Betong.

3. As the aforesaid land is required by the Government, the Government has to acquire it. In consequence thereof, all native customary rights over such land shall be taken over by the Government subject to the payment of compensation under section 5(3) of the Land Code.

4. As from the date of coming into force of this Direction, all native customary rights over the said land shall cease to subsist and the said land shall revert back to the Government for the aforesaid public purpose.

5. Any person having any lawful claim to native customary rights over the said land or any part thereof and whose rights are affected by this Direction shall within sixty (60) days from the date of publication of this Direction in a newspaper circulated in Sarawak, submit his claim, together with evidence in support thereof, to the Superintendent, Lands and Surveys Department, Betong Division, Betong in a form prescribed by the Superintendent and obtainable from his office in the said Department. Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
