(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Planning and Resource Management has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 38) 2011 Direction, and shall come into force on the 29th day of March, 2011.

2. All those areas of land situated at Jalan Nanga Salim, Sibul known as Plot A, Plot B & Plot C containing a total area of approximately 689.22796 square metres, as more particularly delineated on the Plan Print No. 3/3D(V41/2010) and edged thereon in red, are required for public purposes, namely for Bridge at Sungai Salim 3.
