THE LAND CODE

THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 2) 2014 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 2) 2014 Direction, and shall come into force on the 13th day of March, 2014.

2. All that area of land situated at Sungai Sibatu, Suai, Niah, Miri known as Plot A, containing an area of approximately 4927.7 square metres, as more particularly delineated on the plan (Print No. 3/AQ/4D/22/2013) and edged thereon in red, is required for a public purpose, namely for the construction of bridge (Bridge over Sungai Sebato, Access Road to SRK Sebato, Miri). Further details regarding the land can be obtained from the office of the Superintendent of Lands and Surveys, Miri Division, Miri.

3. As the aforesaid land are required by the Government, the Government has to acquire it. In consequence thereof, all native customary rights over such land shall be taken over by the Government subject to the payment of compensation under section 5(3) of the Land Code.
