THE NATIONAL PARKS AND NATURE RESERVES ORDINANCE, 1998

THE GUNUNG LESONG NATIONAL PARK NOTIFICATION, 2010

(Made under section 10(1))

Pursuant to section 10(1) of the National Parks and Nature Reserves Ordinance, 1998 [*Cap. 27*], the Minister has made the following Notification:

1. This Notification may be cited as the Gunung Lesong National Park Notification, 2010.
2. The area intended to be constituted as a National Park is described in the Schedule and to be known as the Gunung Lesong National Park.
3. Any person claiming any rights or privileges in or on such land described in the Schedule is required to submit his claim in writing or in person to the Chief Park Warden, Kuching Region, within sixty (60) days from the date of publication of the Notification, together with evidence in support of such claims.
4. Upon the expiry of these period of sixty (60) days from the date of publication of this Notification, no claim to any rights or privileges in or over the area intended to be constituted a national park shall be entertained and any such rights or privileges, if any, shall be deemed to have been abandoned or the exercise thereof has been waived, by any person entitled thereto.
