THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 42) 2014 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 42) 2014 Direction, and shall come into force on the 10th day of July, 2014.

2. All that area of land situated at Tanjung Tiong, Mukah known as Plot A, containing an area of approximately 1606.5 square metres, as more particularly delineated on the plan (Print No. 8/AQ/10D/26/2012) and edged thereon in red, is required for a public purpose, namely for the construction of tidal control gates (Tidal Control Gates at Point A8b, Tanjung Tiong Drainage Scheme, Mukah). Further details regarding the land can be obtained from the office of the Superintendent of Lands and Surveys, Mukah Division, Mukah.
