THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 50) 2014 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 50) 2014 Direction, and shall come into force on the 8th day of July, 2014.

2. All those areas of land situated between Nanga Sekuau ke SRK Pakoh, Selabi, Ulu Oya, Sibul known as Plot A and Plot B, containing a total area of approximately 20.05 hectares, as more particularly delineated on the plan (Print No. 12A/AQ/3D/18/2013) and edged thereon in red, are required for public purposes, namely for upgrading of road (Menaiktaraf Jalan Nanga Sekuau ke SRK Pakoh, Selabi, Ulu Oya, Sibul). Further details regarding the land can be obtained from the office of the Superintendent of Lands and Surveys, Sibul Division, Sibul.

3. As the aforesaid land are required by the Government, the Government has to acquire them. In consequence thereof, all native customary rights over such land shall be taken over by the Government subject to the payment of compensation under section 5(3) of the Land Code.
