- (c) in the case of an offence punishable by any Rules or Orders made under this Ordinance, the actual value (as estimated by the Director or any person authorized by him) of the forest produce in respect of which the offence has been committed,

by way of compensation for the offence committed with effect from the 1st day of April, 2011.
